- I would like to be a shareholder in the Mulberry Creek Farm CSA Program.
- I understand that the farmers of Mulberry Creek CSA and Copperhead Hill Farm will do their best to provide a bounty of seasonal, local, healthy produce to me as a shareholder, and that I am sharing the risks of natural farming with the farmers – that those risks may occasionally affect the items that are included in my share.
- I understand that the CSA works within the honor system.
- I understand that it is my responsibility to pick up my share within the appropriate time on my designated day, and that I will contact Kramer Homestead / Mulberry Creek Farm / Copperhead Hill Farm when occasional scheduling conflicts prevent picking up my share on time.
- I understand that if my share is not picked up on the designated day and no other arrangements are made, it will be donated at the discretion of the farmers. (May not apply to frozen or long-storage items.)
